

SOFTWARE LICENSE AGREEMENT OF GOWARE SRL FREE DOWNLOAD; EXPIRATION AFTER 60 DAYS.

IMPORTANT-READ CAREFULLY:

GOWARE SRL, ("LICENSOR") IS WILLING TO LICENSE THE ENCLOSED SOFTWARE TO YOU ONLY IF YOU ACCEPT ALL OF THE TERMS IN THIS LICENSE AGREEMENT. PLEASE READ THE TERMS CAREFULLY BEFORE YOU INSTALL THIS SOFTWARE BECAUSE BY EXERCISING YOUR RIGHTS TO MAKE AND USE COPIES OF THE SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS, LICENSOR WILL NOT LICENSE THIS SOFTWARE TO YOU, AND YOU WILL NOT BE ALLOWED TO DOWNLOAD IT.

Ownership of the Software

1. The enclosed Licensor software program ("Software") and the accompanying materials are owned by Licensor and are protected by Italian laws, by laws of other nations, and by the international disposition on the protection of the copyright and the intellectual property. The Licensor shall be entitled to act in any nation to protect its intellectual property rights.

Grant of License:

2. Licensor grants to you the right to load and use one copy of the Software on a single handheld device ("Device") for no more than 60 days. After these 60 days have passed the program will cease to be operating and you can purchase the software from Goware SRL or remove it from your handheld. Consequently, you may load one copy into storage memory of one device and may use it only on that same device.

Restrictions on Use and Transfer

3. If this Software package contains multiple media types, then you may use only type media appropriate for your computer. You may not use the other size media on another computer or loan, rent, transfer, or assign them to another user except as part of the permanent transfer of the Software and all materials (as provided for below). Moreover you may not copy this agreement.

4. The free download ends after 60 days. You may not copy the Software. The use is sole for a promotional scope and for a limited period.

5. You may, during the 60 days period of operating of the program transfer the Software and any accompanying materials (including the most recent update and all prior versions) if you retain no copies and the transferee agrees to be bound by the terms of this Agreement.

Such a transfer terminates your license. You may not rent or lease the Software or otherwise transfer or assign the right to use the Software, except as stated in this paragraph.

6. You may not reverse engineer, decompile, or disassemble the Software.

7. Licensor notices that the Software will perform substantially in accordance with the accompanying materials for a period of 60 days from the date of installation of the Software.

8. LICENSOR DISCLAIMS ALL WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT, WITH RESPECT TO THE SOFTWARE AND THE ACCOMPANYING MATERIALS.

9. In particular no warranty shall be due and no liability shall have to you the Licensor in the case of modification, accident, abuse, or misapplication.

10. IN NO EVENT WILL LICENSOR BE LIABLE TO YOU FOR DAMAGES, INCLUDING ANY LOSS OF PROFITS, LOST SAVINGS, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF YOUR USE OR INABILITY TO USE THE SOFTWARE.

This Agreement is governed by the laws of the State of Italy and the intellectual property right of the Licensor will be protected in any State in which they are violated in accordance with laws there in force or with the provisions of any international treaty able to be applied in Italy or in any other State. The Licensor underlines that in Italy and in other countries copyrights and other intellectual property rights connected to software are protected also by criminal dispositions by law.
